# SHARED UNDERSTANDING

---

- **Undocumented:** an aspiring citizen who came to the U.S. without legal documentation or who has overstayed their visa.
- **Refugee:** a person who has been forced to leave their country in order to escape war, persecution, or natural disaster.
- **Immigrant:** any person who enters a country for permanent residence from another country.
- **Unaccompanied:** a child who has no lawful status, is under the age of 18, and has no parent or legal guardian in the U.S.

# SUPPORT AND INFORMATION FOR FAMILIES

---

- District letter of support
- 2/27 parent forum: *Safe and Welcoming Schools for All*
- IASC (Immigration Advocacy Support Center) and Attorney Michael Doyle
- What are “sensitive locations”? (schools, churches, medical facilities, funerals, weddings, and public demonstrations)
- Immigration enforcement operations increasing around the country

# SUPPORT AND INFORMATION FOR FAMILIES

---

- 80-90% of raids occur between 6-9 a.m. after school drop-offs
- No ICE (Immigration and Customs Enforcement) enforcement in CT, however, it is likely
- Know your rights (what to do if ICE comes to your door)
- Proactive measures (conditional Power of Attorney, emergency plan, citizen parent carpool)
- Keep medical information on-hand
- Community resource table and Bilingual Staff at the Welcome Center

# SCHOOL-BASED SUPPORT

---

- Under federal law, all children, regardless of their citizenship or residency status, are entitled to a K-12 education
- Do not inquire about a student's legal or residency status
- Create welcoming and safe havens for all students
- Children learn best when they feel safe

# SCHOOL-BASED SUPPORT

---

- Inform students and families of their rights (see *Immigrant and Refugee Children: A Guide for Educators*)
- Stress the importance of taking proactive steps (i.e., conditional Power of Attorney).
- Contact Daisy Torres if you are interested in having a “know your rights” workshops with IASC (Immigration Advocacy Support Center) in your building.
- Provide school-based and community resources and services

# SCHOOL-BASED SUPPORT

---

- Reassure parents schools are considered “sensitive locations”.
- ICE (Immigration and Customs Enforcement) officials may not inquire about a student or family without a signed warrant by a federal judge.
- Suspicious inquiries about a student or family should be directed to the building principal.
  - I. Principals should contact Daisy Torres with specific questions.
- Provide social/emotional support for students (i.e., counseling services)

# SCHOOL-BASED SUPPORT

---

- Identify someone at your school who can serve as the resource advocate in your building. Please forward names to Daisy Torres by March 3<sup>rd</sup>.
- Ensure staff receive *Immigrant and Refugee Children: A Guide for Educators*
- Be cautious-Be skeptical-Be informed
- Encourage families and building administration to attend New London's Parent Forum on February 27, 2017: *Safe and Welcoming Schools for All*
